

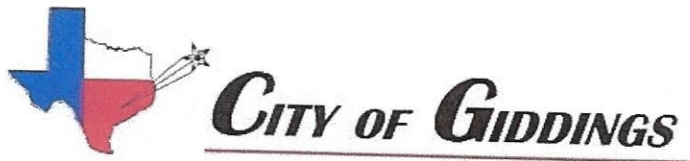

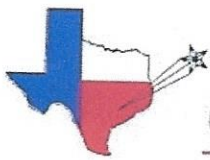
## 8) NEW BUSINESS
