The current lease is up in October of this year 2022. This is a 48-month lease for 20 carts (\$39.95 per cart). The current lease shows that the Golf Course will pay \$799.00 per month. The new 48-month lease with 21 carts will show the Golf Course will be paying \$1,008 (\$48.00 per cart per).

- -Review Downtown Strategic Plan completed recently as it includes many of these items
- *Beautification/Pride in City Appearance
- -Vacant buildings
- -Blight
- *Building Surplus/Rainy Day Fund
