- a) Discuss and take possible action regarding the Ordinance No. 875 canvassing the returns and declaring the results of the General Election held on May 6, 2023.

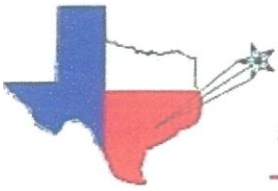
