The City of Giddings has an Annual Financial Report for the year ended September 30, 2021. The city received an unmodified opinion which is the highest level of assurance. The overview audit process was explained and components of the annual financial report financial highlights and City revenues for governmental activities stating the property tax is the highest revenue source. City expenses are the highest in public safety with general government second. Statements and schedules of revenues, expenditures, and the changes in fund balance were explained. The charter states we can only keep auditors for 5 years. This was the last year for the CPA Brooks Watson & Co., PLLC.
