

8. NEW BUSINESS

a. Receive first draft of the City of Giddings 2019-2020 Proposed Budget Presented by City Manager Ricky Jorgensen.

City Manager Ricky Jorgensen presented this item to City Council. This is the first draft of the 2019-2020 City of Giddings proposed Budget. The City Council received the Budget Workbook for 2019-2020. Ricky discussed some the major areas of the Budget but, did not go in to detail. The highlights were 5% cost of living raise, he will explain more later and this will be broken down at a later date. All Department Supervisors have met with Clifton, Ricky and Spencer to explain the needs for the Departments for the Budget 2019-2020. Charts with expenditures fund help to guide the monies spent on what department, and where the money comes from. Ricky stated also what is in the red and black.
