Discussion and take possible action on the Resolution No. 439-2019 by the City of Giddings of Giddings, Texas authorizing an Economic Development Corporation and Economic Development Agreement with Zoch Brewing Company, LLC, D/B/A Giddings Brewhaus in the amount of \$60,000.00. With an additional amount of \$40,000.00 from Friends of the Depot. (Require two readings)

City Manager Ricky Jorgensen presented this agenda item to City Council, Zoch Brewing Company would like to Develop and improve the Old Sterling Theater into a Pub. Zoch Company will expand the building and the and the brewing equipment will be visible from within the Brewery with a large glass partitions. The Resolution No. 439-2019 requires two readings at this time. There will be no action on the first reading.

h. Discussion and take possible action on the Resolution No. 440-2019 by the City of Giddings of Giddings, Texas authorizing an Economic Development Corporation to expand up to \$35,000.00 for the renovation for the historic train station. (Require two readings)

City Manager Ricky Jorgensen presented this agenda item to City Council, the EDC would like to further enhance The improvements to the business and the Community as a Whole. The Resolution No. 440-2019 requires two readings at this time. There will be no action on the first reading.

i. Discussion and take possible action on the Resolution No. 441-2019 by the City of Giddings of Giddings, Texas authorizing an Economic Development Corporation to expand up to \$25,000.00 for the development for the Giddings Heritage Museum and landscaping, water taps, signage and marketing materials related to the Depot Complex. (Require two readings)

City Manager Ricky Jorgensen presented this agenda item to City Council, the EDC would like to further enhance the Property and also provide marketing materials to show case the property and will improve the economic impact. The Resolution No. 441-2019 requires two readings at this time. There will be no action on the first reading.

j. Discussion and take possible action on the Lee County Youth Center which is requesting a long-term lease with the City of Giddings for a new location for the LCYC.

Mayor Pro-Tem Joel Lopez presented this item as a Member of the Board of the Lee County Youth Center. Joel stated the Board Members Present at this time Jennifer Ashley, Sandra Lopez and Meredith Franks. Joel passed out sheets of the History of LCYC, at this time the LCYC has been displaced due to the health Safety concerns with the former Giddings Elementary School. As of July 2019, the LCYC has been relocated to The First Presbyterian Church and is seeking every avenue available to get funding from the public and continue to have fundraisers for a plan of action to pursue and fulfill the dream of moving and having our own facility.

The Board Members of LCYC has found a new location and feels the best location for the facility would be next to the Simmang Park on North Dallas Street. Specifically is property ID Numbers 12034 & 14567 which is not currently being utilized. LCYC is seeking a long-term lease agreement to utilize this property to build a facility conductive to learning, with a shelter area for recreation for any weather condition. The plans are currently are for a study area, kitchen, offices, bathrooms and a regulation size basketball court/gym. Showers to be added in the near future, maybe used for a Red Cross Shelter for a natural disaster in our area. Parking lot in the rear to the building.



The LCYC has investors willing to help in some way, the building estimated cost is \$450,000.00. The lease with this property would mean that any improvements would return to the City of Giddings should LCYC dissolve and the investors have agreed to this.

Joel Lopez recused himself to vote on this agenda item.

A motion was made by City Council Member Jake Horne and seconded by Council Member Linda Pruitt action on the Lee County Youth Center which is requesting a long-term lease with the City of Giddings for a new location for the LCYC.
