e&f) Mayor Dowell called Council, City Manager, EDC Director Tonya Britton, EDC President John Simmang, and City Attorney into Executive Session at 7:46 p.m., regarding GEDC request to purchase real property, in accordance with the Texas Government Code, Section 551.072 and Economic Development Negotiations, in accordance with the Texas Government Code, Section 551.087.

Mayor Dowell reconvened the open session at 8:33 p.m., and stated that no action was taken.

g) Mayor Pro Tem Fred Jones moved to approve the action taken by GEDC to purchase the Union Pacific property, approximately 3.6 acres, which sits adjacent to Hwy 290 and is contiguous with the approximately 167.257 Mittasch estate, for \$20,000 per acre, and to authorize John Simmang to sign any paperwork needed to complete the transaction; secondarily authorize John Simmang to sign any documents needed relating to the TxDOT easement and signal light activities; third and to approve GEDC to purchase the approximately 167.257 acres of land from the Mittasch estate, for \$10,000 per acre – less the cost of the approximately 1.39 acres of County Road 133, less 50% of the cost to purchase the Union Pacific property referenced above last item contingent upon the termination and release of the Duke gas pipeline easement located on the property. The motion seconded by Council Member Alan Casey.
