

## DIVISION 4. GOLF COURSE RULES

### Sec. 1.10.079 Golfers

There can be NO more than 6 people per group/per hole.

If you are playing in a Group you must have 2 people per cart.

Member if you have a guest come play golf with you, you must sign in the guest.

Members if you're here before your guest please let the Golf Course employee know you are having a guest come play golf with.

Guest if the member you are playing golf with leaves you may not take the members cart and continue playing.

### Sec. 1.10.080 Cart Path

Observe 90 degree rule with carts-use paths.

### Sec. 1.10.081 Tournament Rates/Rules (Attachment "C" is on file at the Giddings Golf Course)

1. \$20 per cart, per 18 holes.  
\$150.00 deposit is required before facility will be reserved for tournament.
2. Outside items brought onto City premises, must be approved by City and removed by 6pm the day of the tournament.  
Items that may be approved are: tents, BBQ pits.  
Items not allowed: beer and soft drinks.
3. If rain occurs before start of tournament or less than ½ completed, tournament will rescheduled. If rain occurs after ½ of tournament completion the tournament shall be called finished and winners based upon standings at that time.
4. The facility will be open at 8am on the rental date needed.
5. Beer and soft drinks must be purchased from the Giddings Country Club. All laws that apply to the sale & consumption of alcohol will be strictly enforced. Only persons of legal age may serve beer.  
Purchases and/or drinking of alcoholic beverages by minors on premises is not allowed. Beer cannot be sold or consumed on premises until noon on Sunday and 8am on weekdays.
6. Renter must contact Giddings Country Club at least 10 days prior to event, to order beer & soft drinks.
7. No smoking, including e-vapor cigarettes is permitted in the hall, restroom or cantina area at any time.
8. No pets allowed.

### Sec. 1.10.082~~2~~ Tournament Guests or Participants Operation of Equipment Rules:

1. Must be 16 and show identification to drive a cart. Each driver must fill out a wai~~v~~ier to be kept on file.  
Only 2 persons per cart at a time.

### Sec. 1.10.083 Forfeiture of Deposit(s) Will Result If:

1. Cancellation is not given at least 10 days prior to scheduled event.
2. If children are not supervised.
3. Tobacco products, including e-vapor cigarettes are used in buildings.
4. A fire alarm is set off without proper justification\_(which is illegal & may result in criminal charges being filed).^

5. Any City property is damaged.
6. Excessive trash is not properly disposed in dumpster.

**Sec. 1.10.0844 Liability**

1. The City is not liable for any loss of personal belongings and/or for any accidents occurring on the premises involving property damage and/or personal injury of the renter and/or their guests. Moreover, the Renter is liable for any damage resulting from misuse of City of Giddings property and for any personal injury and/or property damage that may be suffered or incurred by Renter or its guests while traveling from the facility during or after the rental period. Renters shall indemnify city for claims resulting therefrom.

**Sec. 1.10.0855 Hall Rental - (Attachment "D" is on file at the Giddings Golf Course)**

1. Rental Rates:
  - a. Hall Facilities (capacity 125) including kitchen \$200.00
  - b. Security Officer (\$35/hour, per officer, minimum of 2 officers)
  - c. City of Giddings employee (\$25/hour, minimum 3 hours)
  - d. Deposit (to be refunded if hall is clean) \$200.00
  - e. Hall use before and/or after rental date when available. \$ 50.00 per day
  - f. Additional time after 9:00 p.m. \$ 25.00 per hour
  - g. Additional time after 9:00 p.m. per security officer \$ 35.00
2. Hall Hours: 8:00 am – 9:00 pm (9:01 pm – 12:00 am extra cost)
3. Kitchen Facilities:
  - a. Kitchen is equipped with a refrigerator and a 6-burner gas range with 2 ovens.

**Sec. 1.10.0866 Golf Course Membership**


1. Membership fees and rules are not printed in this code but are on file at the Giddings Golf Course. (Attachment "E")


**Effective Date.** This ordinance shall become effective thirty (30) days after its passage.
