- f. Discuss and take possible action to approve the proposed lateral transfer vacation policy from the Giddings Police Department.

City Manager Spencer Schneider presented this agenda item to Mayor and City Council. I sent you an e-mail last week outlining this agenda item. It is also in your agenda packet. Police Chief Bill Weems is here to answer any questions or concerns you may have. Police Chief Bill Weems stated it is hard to get employees and is hard not give raises or keep employees when another city pays more then we do. Chief Bill Weems asked to give the employees with the experience with the job more vacation. This would cause to budget more overtime for next year.

Mayor Pro-Tem Alan Casey stated we need to have options for the police officers to want to stay in and work and live in Giddings. Mayor Pro-Tem Alan Casey stated as of now all of the City of Giddings property taxes go toward the Giddings Police Department to finance it. We as a governing body need to come up with ways to attract a younger generation to Giddings. As the City of Giddings, we need to exhaust all of our options before we go this extreme. The Police Officers need to have a residence here in Giddings. This helps show the tax payers where the property taxes are being spent. Mayor Pro-Tem Alan Casey asked to postpone the agenda item until further research is done, and stated we need new tools to market the police department.

9. CITY MANAGER'S REPORT AND ANNOUNCEMENTS:


1. The new irrigation system project is going great at the golf course. The water well is in the completion stage. The irrigation system on the north side is almost complete. All of the pipe for that section is in and covered.
2. The CDBG grant application preliminary scores came in, and Giddings scored 199.6 out of 200 points. We contacted our grant consultant, and he states we will probably receive the \$750,000 grant. The grant will be for the fire department for one of the fire apparatus purchases.
3. Heather and myself are going forward with second phase of the Certificate of Obligation Bonds for street reconstruction, water, waste water line replacement, and a new fire apparatus purchase. We will be bringing this item back to council when we have more information from our bond consultant.
4. The Charter Review Committee is making progress with the review process. They will meet again on January 09, 2025. When finished with the review process, they will bring a recommendation back to council with recommended changes. Once the council approves the changes, the changes will go on the general election ballot on May 03, 2025 for adoption.
