RULES & REGULATIONS

1. Members may only enter the premises during working hours
2. Members MUST CHECK-IN upon entering the facilities ~ **NO EXCEPTIONS** ~
3. Members MUST be present for their guests to play
4. Members/Guests MUST be at least 16 years of age with a valid Driver's License to operate a golf cart (Rental and/or Personal Carts) No Permits!
5. Members are limited to 1 Bucket of Range Balls per 9 holes played
6. Members MUST check-in after each 18 holes played
7. Members MUST have a current membership, cart waiver, payment agreement, and valid ID on file. This MUST be **RENEWED EVERY YEAR**. May be required to show ID at any given time.

8. Membership dues MUST be kept current, or membership **WILL be TERMINATED** if payment has not been received for 2 BILLING CYCLES.
9. **Any returned item or INSUFFICIENT FUNDS will be charged a \$30 fee.**
10. Members MUST maintain proper conduct and observe golf etiquette at all times while on premises
11. Only service animals and pets on a leash are allowed at the golf course
12. Members **WILL NOT** bring any outside alcohol onto the premises
13. Members and guests will dispose of smoking materials in proper receptacles and not on golf course, lawn, parking lot or any other part of the facility
14. While driving any cart on the course, members/drivers MUST stay on authorized trails, must avoid the driving range, and must not remove any fencing or damage any part of the facilities
15. Members MUST report any damage to City of Giddings property to golf course personnel immediately
16. The City of Giddings, the Giddings Municipal Golf Course and all personnel are not responsible for personal items brought onto the premises
17. City of Giddings employees have the authority to enforce all rules, regulations and policies set forth as stated above

LIABILITY

The City of Giddings Golf Course and Country Club is not liable for any loss of personal belongings and for any accidents occurring on the City’s premises involving property damage and/or personal injury of the member and/or guests. Moreover, excluding normal use, the member is liable for any damage resulting from the misuse of the City’s property (such as hitting a stationary object with a cart, etc.) and for any personal injury and/or property damage that may be suffered or incurred by member or guests while traveling to and from the facility.

INDEMNIFICATION

The member agrees to INDEMNIFY and HOLD HARMLESS the City of Giddings Golf Course and Country Club from any and all liability of expense the City (and/or its officers, members or employees) may suffer or incur as a result of any claim that may be asserted against the City arising from the member’s use of the premises except for any claim which is based on the intentional misconduct of the City of Giddings Golf Course and Country Club.

MEMBER’S RESPONSIBILITY

The member is solely responsible for the behavior of its guest. All minor children must be supervised at all times by the parent or responsible adult. The member agrees to maintain orderly conduct of its guests and to uphold the laws under which the City of Giddings Golf Course and County Club operates the facility. Upon failure to maintain such law and order, the member agrees to assume and reimburse the City of Giddings for any expense that the City may incur to maintain such law and order. Moreover, the City of Giddings reserves the right to terminate the member’s contract, free of any further obligation by the City of Giddings to the member where law and order is not maintained.

ACCEPTANCE OF RULES

- I, the undersigned, understand this is a binding contract and cannot be cancelled by me for at least one year from the date listed below.
- I, the undersigned, understand that The City of Giddings Municipal Golf Course and Country Club may at any time, due to non-payment of membership dues and/or breaking of rules and regulations, cancel my membership.
- I, the undersigned, that I am to show formal identification or my membership card upon entering the facility and that no guests are allowed to play on my membership unless I am present.
- I, the undersigned, understand that by signing as the “responsible party” I am agreeing to all terms and conditions for all members on my membership plan and I take responsibility for their actions.

By its execution below, the member agrees to abide by all the rules and provisions set forth above and to be bound by the terms hereof. You must be at least 18 years of age to sign this contract.

Member Contract

I represent that I am familiar with the operation and use of said Electric/Gas Cart, and that I can operate and control same.

I will only have no more than two people in that Electric/Gas Cart at any time and these people will sit in the vehicle's seat while the Electric/Gas Cart is in motion. There will be no riding on the hood or back of said Electric/Gas Cart.
